amended from time to time ("RESPA"), except that the cushion or reserve permitted by RESPA for unanticipated disbursements or disbursements before the Borrower's payments are available in the account may not be based on amounts due for the mortgage insurance premium.

- 13. Notices. Any notice to Borrower provided for in this Security Instrument shall be given by delivering it or by mailing it by first class mail unless applicable law requires use of another method. The notice shall be directed to the Property Address or any other address Borrower designates by notice to Lender. Any notice to Lender shall be given by first class mail to Lender's address stated herein or any address Lender designates by notice to Borrower. 18. Foreclosure Procedure. If Lender requires immediate payment in full under paragraph 9, Lender may invoke the power of sale and any other remedies permitted by applicable law. Commencing at the N1/4 corner of said Section 19; thence South along the North-South centerline of said Section 19 1320.00 feet more or less, to the Northwest corner of the SW1/4 of the NE1/4 and the TRUE POINT OF BEGINNING of the hereinafter described tract of land; thence continuing South along said North – South centerline 1320.00 feet more or less, to the center of said Section 19, thence East 660.00 feet, more or less, to the Southwest corner of the W1/2 of the SW1/4 of the NE1/4 of said Section; thence North along the East line of the W1/2 of the SW1/4 of the NE1/4 1320.00 feet, more or less, to the Northeast corner thereof; thence West 660.00 feet, more or less, to the true point of beginning.
