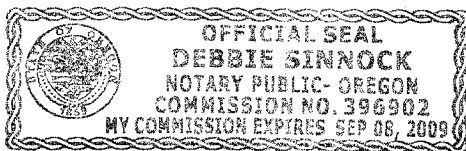

LEGAL DESCRIPTION

Lot 4, Block 13, FIRST ADDITION TO BLY, Klamath County, Oregon, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

ALSO

Beginning at the Southeasterly corner of Lot 5, Block 13, FIRST ADDITION TO BLY, Klamath County, Oregon; thence along the Southerly line of said Lot 5 North $88^{\circ} 47'$ West 46 feet; thence parallel with the Easterly line of said Lot 5 North $1^{\circ} 13'$ East 70.6 feet, more or less to the Northerly line of said Lot 5; thence along the Northerly line of said Lot 5 South $83^{\circ} 37'$ East 46.04 feet, more or less to the Northeast corner of said Lot 5; thence along the Easterly line of said Lot 5 South $1^{\circ} 13'$ West 58.86 feet to the point of beginning, being a strip of land 46 feet in width measured off the Easterly side of said Lot 5 in said Block 13.
