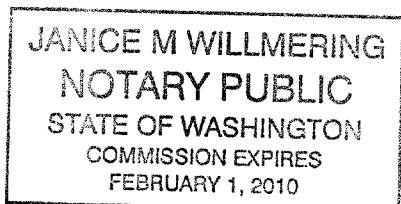

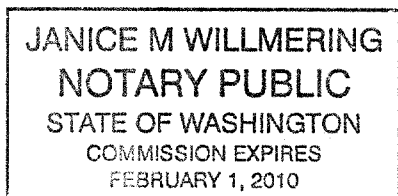
✓ DEED OF RECONVEYANCE WITHOUT SATISFACTION
