MEMORANDUM OF AGREEMENT

The Agreement provides in part that Sprint/Nextel has the right to enter upon certain real property owned by Owner and located at 10714 Springfield Road, City of Klamath Falls, County of Klamath Falls, State of Oregon, as further described in the Agreement (the "Site") for the purpose of performing investigations and tests and, upon finding the Site appropriate, to lease the Site for the purpose of installing, operating and maintaining a communications facility and other improvements. The term of Sprint/Nextel's lease and tenancy under the Agreement is 5 years commencing on the earlier to occur of start of construction of the Facilities (as defined in the Agreement) or eighteen (18) months following the Effective Date, whichever first occurs ("Term Commencement Date"), and is subject to 5 renewal terms of 5 years each that may be exercised by Tenant.
