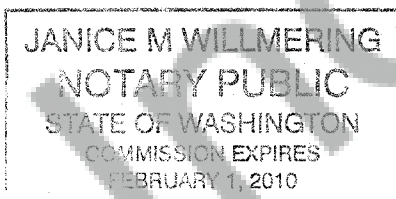

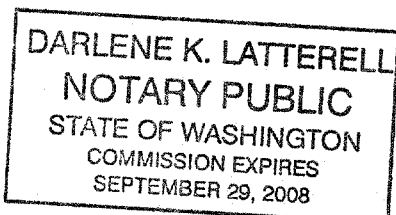
DEED OF RECONVEYANCE

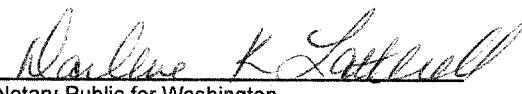
