#### SECOND TRUST DEED

THIS SECOND TRUST DEED, made this 1 St day of May, 2007, between William Henry Hampton, III and Helen Louise Hampton, as Trustees of the William Henry Hampton, III and Helen Louise Hampton Revocable Living Inter Vivos Trust U/A 11/17/2005, as Gruntor, First American Title Insurance Company of Oregon, as Trustee, and Cyndo Landers, as Beneficiary,

#### WITNESSETH:

Grantor irrevocably grants, bargains, sells and conveys to trustee in trust, with power of sale, the property in Klamath County, Oregon, described as:

together with all and singular the tenements, bereditaments and appurtenances and all other rights thereunto belonging or in anywise now or hereafter appertaining, and the rents, issues and profits thereof and all fixtures now or hereafter attached to or used in connection with the property.

At any time and from time to time upon written request of beneficiary, payment of its fees and presentation of this deed and the note for endorsement (in case of full reconveyances, for cancellation), without affecting the liability of any person for the payment of the indebtedness, trustee may (a) consent to the making of any map or plat of the property; (b) join in granting any essement or creating any restriction thereon; (c) join in any subordination or other agreement affecting this deed or the lien or charge thereof; (d) reconvey, without warranty, all or any part of the property. (2) to the obligation secured by the trust deed. (3) to all persons having recorded liens subsequent to the interest of the trustee in the trust deed as their interests may appear in the order of their priority and (4) the surplus, if any, to the grantor or to

any successor in interest entitled to such surplus.

16. Beneficiary may from time to time appoint a successor or successors to any trustee named berein or to any successor trustee appointed hereunder. Upon such appointent, and without conveyance to the successor trustee, the latter shall be vested with all title, nowers and duties conferred upon any trustee herein named or appointed hereunder. Each such appointment and substitution shall be made by written instrument executed by beneficiary, which, when recorded in the mortgage records of the county or counties in which the property is situated, shall be conclusive proof of proper appointment of the successor trustee.

17. Trustee accepts this trust when this deed, duly executed and acknowledged, is made a public record as provided by law. Trustee is not obligated to notify any party hereto of pending sale under any other deed of trust or of any action or proceeding in which granter, beneficiary or trustee shall be party, unless such action or proceeding is brought by trustee.

The granter covenants and agrees to and with the beneficiary and the beneficiary's auccessor in interest that the grantor is lawfully seized in fee simple of the real property and has a valid, unencumbered title thereof, except as may be set forth in an addendum or exhibit attached hereto, and that the grantor with warrant and forever defend the same against all persons whomsoever.

## EXHIBIT "A" LEGAL DESCRIPTION

# PARCEL I

Lots 1, 2, 3, 4, 5, and 6, Block 1 and all that portion of Lots 1, 2, 3, 4 and 5, Block 12, lying Northeasterly of the right of way of Highway 97, all in CHELSEA ADDITION to the City of Klamath Falls, Oregon, now vacated.
