BARGAIN AND SALE DEED

KNOW ALL MEN BY THESE PRESENTS, That Lois M. Montgomery Lao, hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto Ralph Lao, hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anyway appertaining, situated in the County of **Klamath**, State of Oregon, described as follows, to wit

That portion of Lot 3, Block 4, Tract 1083 – CEDAR TRAILS, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, described as follows:

Beginning at a 5/8" inch iron pin at the Southwest corner of Lot 3, Block 4; thence South 69° 59' 42" East 294.43 feet along the South line of Lot 3, Block 4, to a 5/8" iron pin; thence along the arc of a 170.00 foot radius curve to the left (0 = 20° 09' 43", L.C. = S. 80° 19' 02" E. 59.52 feet) 59.82 feet to a 5/8" iron pin on the South line of Lot 3, Block 4; thence North 0° 51' 14" West 421.56 feet to a 1/2" iron pin the North line of Lot 3, Block 4; thence South 89° 45' 10" West 328.83 feet along the North line of Lot 3, Block 4, to a 1/2" iron pin at the Northwest corner of Lot 3, Block 4; thence South 00° 02' 28" West 309.34 feet along the West line of Lot 3, Block 4 to the point of beginning.

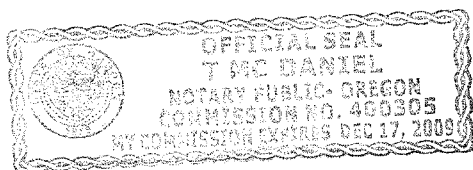
In construing this deed, where the context so requires, the singular includes the plural and all grammatical changes shall be made so that this deed shall apply equally to corporations and to individuals.
