**In Witness Whereof** the said vendor has executed this Memorandum May 31, 2007.

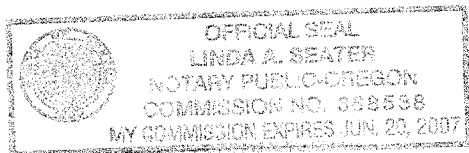


