Reference is made to that certain trust deed made by Debra Repayo and David Montero, as grantor, to Paul S. Cosgrove, Esq., as trustee, in favor of Budget Finance Company, as beneficiary, dated January 31, 2006, recorded February 22, 2006, in the mortgage records of Klamath County, Oregon, as Volume M06, page 03343, the beneficial interest thereafter being assigned to Budget Funding I, LLC, a Delaware limited liability company, by instrument recorded September 26, 2006 in Volume 2006, page 019322, covering the following described real property situated in the above-mentioned county and state, to-wit:

The undersigned hereby certifies that no assignments of the trust deed by the trustee or by the beneficiary and no appointments of a successor trustee have been made except as recorded in the mortgage records of the county or counties in which the above-described real property is situated, further, that no action has been instituted to recover the debt, or any part thereof, now remaining secured by the trust deed, or, if such action has been instituted, such action has been dismissed except as permitted by ORS 86.735(4).

Monthly payments due March 24, 2007, through May 24, 2007, for a total of \$2,828.46, plus late charges of \$94.28, plus corporate advances of \$1,339.95, plus that portion of real property taxes now due for 2005-06 and 2006-07.

By reason of the default, the beneficiary has declared all sums owing on the obligation secured by the trust deed immediately due and payable, those sums being the following, to-wit:

As of March 24, 2007, the principal sum of \$100,520.48 plus interest; plus any sums advanced by the beneficiary or beneficiary's successor in interest for the protection of the above described property, plus attorney and trustee's fees incurred by reason of said default.
