# GRANT OF PERMANENT EASEMENT for 1-C-3-A DRAIN OF THE 1-C DRAIN SYSTEM KLAMATH PROJECT, OREGON

THIS GRANT OF EASEMENT, made this 24 day of April , 2007, by the Gallica Four/KF24, LLC, a State of Washington Limited Liability Company, hereinafter the Grantor; and the United States of America, hereinafter the Grantee, acting by and through the Regional Director, Mid-Pacific Region, Bureau of Reclamation, for the Secretary of the Interior, pursuant to the Federal Reclamation Laws, being the Act of June 17, 1902, and acts amendatory thereof and supplementary thereto, and particularly to Section 14 of the Reclamation Project Act of August 4, 1939, (53 Stat. 1187) which provides for exchanging Reclamation lands for privately owned lands in connection with the relocation of water conveyance facilities.

#### WITNESSETH:

The following grants, rights, and mutual covenants by and between the parties hereto which are acquired for the use of the Bureau of Reclamation, Department of the Interior, its agents, or assigns:

1. For the consideration hereinafter expressed, the Grantor does hereby grant, bargain, convey, and confirm unto the Grantee, its successor and assigns, the rights, privilege, and permanent easement to layout, construct, reconstruct, inspect, operate, and maintain the 1-C-3-A Drain, together with all necessary appurtenances, fixtures, facilities, and devices, used or useful in the operation of said drain through, over, under, and across the lands as shown on Exhibit "A" and more particularly described in Exhibit "B", both of which Exhibits are attached hereto and made a part hereof.



Said drain will remain the property of and be maintained by the United States, its successors and assigns.

- 2. The Grant of Easement herein contained shall include the right to (a) trim, cut, fell, and remove underbrush, obstructions, and any other vegetation, structures, or obstacles within the limits of the easement, (b) store vehicles, equipment, and construction materials, and (c) such other uses requisite in the construction, operation, use and maintenance of said drain, including rights of access for ingress and egress to the land described in Exhibits "A" and "B".
- 3. The Grant of Easement herein contained is subject to existing rights-of-way for highways, roads, railroads, canals, laterals, ditches, pipelines, electrical transmission lines, telegraph and telephone lines on, over and across the lands described in said Exhibits "A" and "B" and to any mineral rights of record outstanding in third parties on the date of this Grant of Easement.
- 4. As complete compensation and consideration for this Grant of Easement and the use of said land by the United States, the United States has agreed to Quitclaim its interest in a portion of the existing easement held by the United States to the Gallica Four/KF24, LLC, in accordance with the terms and conditions of an unrecorded Agreement among the Gallica/Four/KF24, LLC, the United States, and the Klamath County Drainage Service District, entitled Relocation Agreement for Abandonment and Relocation of 1-C-3-A Drain System, and dated July 21, 2006.


