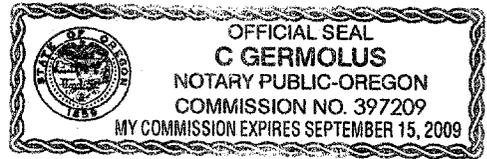

EXHIBIT A
