EXHIBIT "A"
LEGAL DESCRIPTION

A portion of Government Lot 3, Section 31, Township 37 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, said tract being 40 feet in width, 20 feet on either side of the herein described centerline:

Beginning at a point in the East boundary line of the Dalles-California Highway which bears from the Northwest corner of said Lot 3; South $1^{\circ} 05'$ West, 328.5 feet, thence North $73^{\circ} 54'$ East, 69.2 feet; thence South $16^{\circ} 06'$ East 27 feet. From this true point of beginning, said tract to be 40 feet wide. 20 feet on each side of a center line described as bearing South $16^{\circ} 06'$ East 55.9 feet; thence South $63^{\circ} 21'$ East 770 feet to a point being the termination of said center line.

More commonly known as Shadow Lane
