JURISDICTION AND VENUE

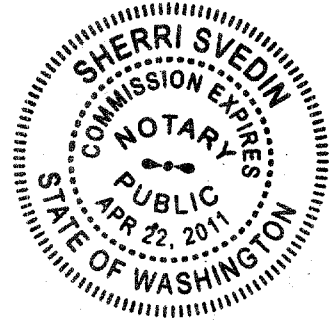
