## TRUSTEE'S DEED

THIS INDENTURE, made July 17, 2007, between Northwest Trustee Services, Inc., hereinafter called the Trustee and Deutsche Bank National Trust Company, trustee, hereinafter called the second party;

## **RECITALS:**

RECITALS: Kim Montgomery, as grantors, executed and delivered to: Amerititle, as trustee, for the benefit of Home123 Corporation, as beneficiary, a trust deed dated 05/25/05, duly recorded on 05/31/05 in the mortgage records of Klamath County, Oregon in Vol M05 Page 40321 and subsequently assigned to Deutsche Bank National Trust Company,trustee for HSBC BANK (USA) INC- HIS ASSET SECURITIZATION CORPORATION TRUST 2005-NC2 (HASCO 2005-NC2) by Assignment recorded as 2007-04052. In the trust deed, the real property described below ("Property") was conveyed by the grantor to the trustee to secure, among other things, the performance of the grantor's obligations to the beneficiary. The grantor thereafter defaulted in the performance of those obligations and such default(s) still existed at the time of the trustee's sale of the Property described below.

Because of the default(s), the record beneficiary under the trust deed or its predecessor declared all sums secured by the trust deed immediately due and owing; therefore, a Notice of Default, containing an election to sell the Property and to foreclose the trust deed by advertisement and sale to satisfy grantor's obligations owed to the beneficiary was recorded in the mortgage records of the county in which the Property is located on 03/12/07, in 2007-04054.
