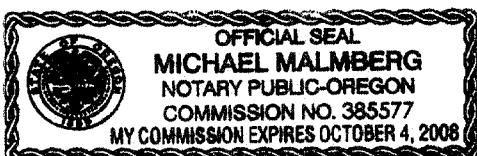

**LEGAL DESCRIPTION**

A parcel of land situated in Tract 38 of MERRILL TRACTS, in the county of Klamath, State of Oregon, more particularly described as follows:
