MAULDIN, Trustee under the Mauldin Loving Trust dated March 5, 1996, grantee herein, her successors and assigns, a non-exclusive permanent easement for road right-of-way purposes upon the existing road located upon the following described real property, to-wit:



The easement given herein is for ingress and egress for road access purposes from Oregon State Highway 140 to the property of Grantee more specifically described as follows, towit:

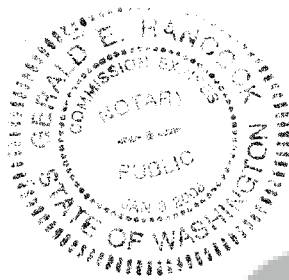
