## **EXHIBIT A**

## LEGAL DESCRIPTION:

A portion of Lots 4 and 5 Block 2 Fairview No. 2 (also being known as Fairview Addition No. 2) to the City of Klamath Falls, Oregon, more particularly described as follows:
