## **RECITALS**

A. Grantor executed and delivered to Beneficiary an Oregon Trust Deed, Security Agreement, and Assignment of Rents and Leases dated November 7, 2006, and recorded on November 9, 2006, as document No. 2006-022484 in the real property records of Klamath County, Oregon (as amended, the "Trust Deed"), granting an interest in the real property described as follows:

Lots 5 and 6, Block 19, and Lots 11 and 12, Block 20, SECOND ADDITION TO THE CITY KLAMATH FALLS, according to the official plat thereof on file in the office of the Clerk of Klamath County, Oregon

- B. The Trust Deed secures payment of, among other things, credit facilities provided by Beneficiary for the benefit of Grantor.
- C. Grantor, among others, has requested that Beneficiary provide certain accommodations regarding the existing credit facilities. Beneficiary is willing to make these accommodations provided that, among other things, Grantor executes this amendment.

## **AGREEMENT**

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor and Beneficiary hereby agree as follows:

1. <u>Amendment</u>. The Trust Deed is hereby amended by revising the

"Obligations means all loans by Beneficiary to Camco Development and Construction, Inc., evidenced by a note or notes dated November 7, 2006, April 19, 2006, and February 22, 2006, in the initial principal amounts of \$257,000, \$55,000, and \$80,000, respectively, and any extensions, renewals, restatements, and modifications thereof and all principal, interest, fees, and expenses related thereto (collectively, the "Note"); . . .. '

Continuing Validity. Except as expressly modified by this amendment, the terms of the Trust Deed remain unchanged and in full force and effect. Consent by Beneficiary to this amendment does not waive Beneficiary's right to require strict performance of the Trust Deed, as changed above, nor does it obligate Beneficiary to agree to any further amendments.
