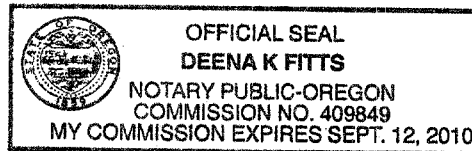


EXHIBIT "A"

A tract of land situated in the NE 1/4 of Section 29, Township 39 South, Range 12 East of the Willamette Meridian, more particularly described as follows: Beginning at the Northeast corner of Section 29, Twp. 39 S.R. 12 E.W.M.; thence South along the East line of said Section 29, 660 feet to the true point of beginning; thence West parallel to the North line of said Section to a point that is 20 feet East of the Easterly right of way line of the Lee Lateral of the Main East Canal; thence Northerly parallel to and 20 feet East from the Easterly right of way line of said Lee Lateral to the North line of said Section; thence Westorly along said North line to the Easterly right of way line of the said Lee Lateral; thence Southerly along the Easterly line of said Lee Lateral to the South Line of the NE 1/4 of said section; thence East along said South line to the SE corner of the NE 1/4; thence North along the East line of the NE 1/4 to the point of beginning.
