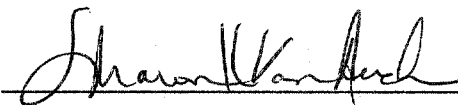
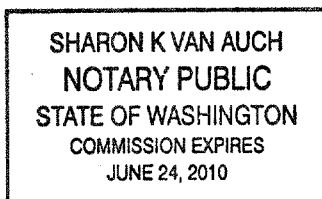

DEED OF RECONVEYANCE

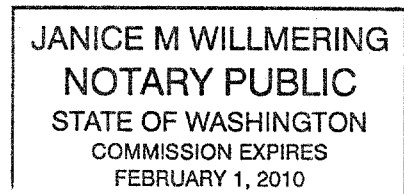

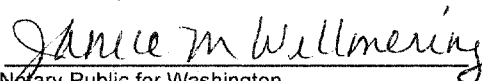
