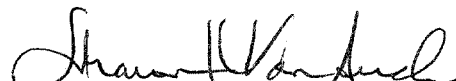

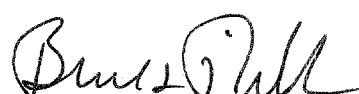

DEED OF RECONVEYANCE

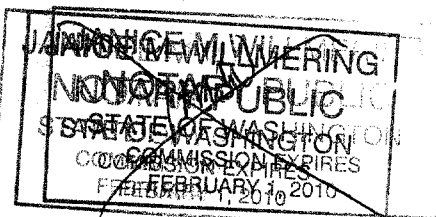

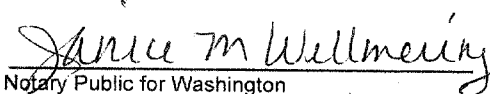
