THIS MODIFICATION OF ASSIGNMENT OF RENTS, LEASES, CONTRACTS AND AUTHORIZATIONS (this "Modification"), is entered into as of August 30, 2007, by and between COLLINS TIMBER COMPANY LLC, an Oregon limited liability company ("Assignor") and AMERICAN AGCREDIT, FLCA, an Agricultural Credit Association chartered pursuant to the Farm Credit Act of 1971, as amended, and THE PRUDENTIAL INSURANCE COMPANY OF AMERICA, a New Jersey corporation (together, "Assignee"), in order to modify that certain Assignment of Rents, Leases, Contracts and Authorizations dated September 7, 2002, from Assignor in favor of Lenders as Assignee, recorded September 10, 2002, in Lake County, Oregon in Book 130 at Page 508, Lake County Mortgage Records and in Klamath County, Oregon in Volume MO2, Page 51416, Klamath County Mortgage Records (herein, the "Assignment"). The terms and conditions of the Assignment, as amended by this Modification, are hereby affirmed and ratified. This Modification is not intended and shall not be construed to impair the validity, priority or enforceability of the Assignment.
