The true and actual consideration for this conveyance is \$195,000.00.

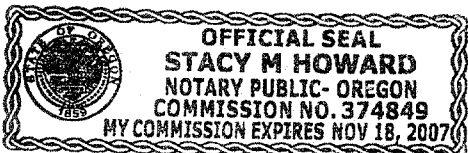
