It is a general rule of common law that an easement may be terminated when the holder (s) of an easement releases his or her rights in the easement to the owner of the servient estate. The release must be in writing.

WHEREAS, on the 28th of July 1997, Carrol J. Scronce and Betty L. Scronce, as Tenants by the Entirety, owners of Land Partition 37-97, being of Lot 6 of Tract 1142 – BURKE PLACE and a portion of Lot 55, MERRILL TRACTS, situated in the NE 1/4 of Section 11, Township 41 South, Range 10 East of the Willamette Meridian, Klamath County, Oregon did create for themselves and their heirs and assigns the 16 foot wide nonexclusive easement for ingress/egress and public utilities to parcels 1,2, and 3 shown of the face of said Land Partition 37-97 filed by Klamath County Clerk on 25 September 1997.

A review of said document reveals that said 16 foot easement runs along the westerly 16 feet of parcels 1, 2, and 3.

WHEREAS, Parcel 1 is owned by Carrol J. and Betty J. Sconce, and Parcel 2 is now owned by Irene Hernandez and Parcel 3 is now owned by Gary R. Robeson, these three owners are now the parties to the certain easement over, under and across the West 16 feet of Parcel 3 of Land Partition 37-97 described above.

WHEREAS, the parties hereto wish to extinguish the 16 foot easement over, under and over, under or across the Westerly 16 feet of Parcel 3. The owner of Parcel 1, Carrol J. and Betty L. Scronce and the owner of Parcel 2 Irene Hernandez, hereby relinquish all interest in and to that certain westerly 16 foot wide easement of Parcel 3 now owned by Gary R. Robeson.

THEREFORE, for valuable consideration, receipt of which is hereby acknowledged, the parties hereby agree that the certain 16 foot wide easement over under and across Parcel 3 for ingress, egress and public utilities of Land Partition 37-97 as described above shall be forever terminated and extinguished for all purposes at the time this agreement is signed by the parties. All rights of any nature related directly or indirectly to the Easement on Parcel 3 shall be forever terminated at this time.


