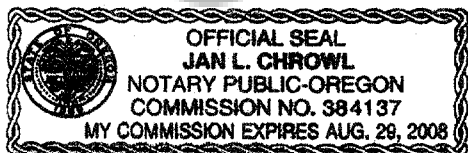

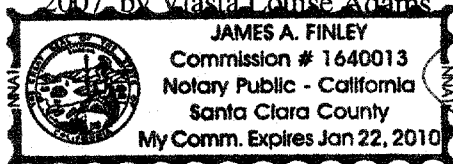

In Klamath County, Oregon:

A portion of Section 16, Township 41 South, Range 12, E. W. M., more particularly described as follows:

Beginning at the East quarter corner of Section 16; thence North  $89^{\circ}46'$  West 1331.37 feet to a point; thence South  $0^{\circ}14'$  West 30.0 feet to a monument on the South boundary of the Merrill-Malin State Highway and the West boundary of First Street in Malin, Oregon; thence North  $89^{\circ}46'$  West 1360.69 feet to a  $5/8$ th inch iron pin on the South boundary of the Merrill-Malin State Highway, which point is the true point of beginning of this description; thence South  $0^{\circ}53'$  East 418.58 feet to a  $5/8$ th inch iron pin; thence North  $89^{\circ}43'05''$  West 435.14 feet to a  $5/8$ th inch iron pin; thence North  $1^{\circ}35'45''$  East 418.24 feet to a  $5/8$ th inch iron pin; thence South  $89^{\circ}46'$  East 417.03 feet along the South boundary of the Merrill-Malin State Highway to the true point of beginning of this description.
