QUITCLAIM DEED



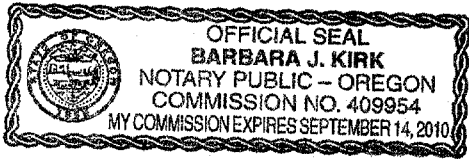
