AMENDMENT TO SHORT FORM LEASE

THIS AMENDMENT TO SHORT FORM LEASE (the "Amendment") is made this 10th day of September, 2007 between Klamath-Hilyard, LLC, an Oregon limited liability company ("Landlord") and AutoZone Development Corporation, a Nevada corporation ("Tenant").




