




Exhibit A

Beginning at a point in the Northerly line of said Lot 11, Block 113, aforesaid, 100 feet Westerly from the Westerly line of California Avenue, and running thence Westerly along the Northerly line of said Lot 11, 61.6 feet, more or less, to the Northwesterly corner of said Lot; thence Southerly along the Easterly line of the alley to an intersection with the line between Lots 10 and 11 in Block 113; thence Easterly along the line between said Lots 10 and 11, 46.3 feet, more or less, to a point 100 feet Westerly from the Westerly line of California Avenue; thence Northerly parallel with California Avenue, to a point of beginning;
