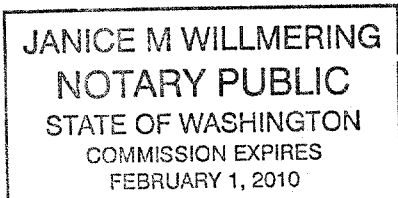

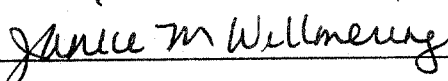

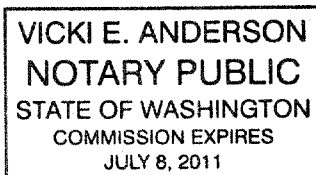
DEED OF RECONVEYANCE
