RECITALS

- A. On July 25, 1975 the Klamath County Clerk accepted for recording the plat map and dedication page for "Tract 1096 Americana Subdivision" (the "Subdivision").
- B. The subdivision plat map states that the owner of the subdivision, Perry Bros. Inc., an Oregon corporation, certifies that "Easements as shown on the annexed map are dedicated to the City of Klamath Falls for regulation and placement of utilities, said easements to provide ingress and egress with any planting or structures placed thereon by the lot owner to be at his/her own risk." The Subdivision plat dedicates a sixteen foot (16') wide utility easement along the southerly boundaries of Lots 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16 and 17 of Block 3 of the Subdivision ("Utility Easement").
- C. The City of Klamath Falls has received a request by certain property owners for the City to release the portion of the Utility Easement as to Lots 6-17, and the City has agreed it is appropriate to do so because no utilities are within said easement and City has determined that the easement is no longer needed and should be released. The portion of the Utility Easement situated on Lot 5 should not be released because it is being used to supply electrical power.

RELEASE AND RELINQUISHMENT OF DEDICATED UTILITY EASEMENT, ON LOTS 6-17, BLOCK 3, OF "TRACT 1096 - AMERICANA SUBDIVISION"

In consideration of the foregoing recitals, the City of Klamath Falls, Oregon, does hereby release and relinquish that certain 16-foot wide utility easement dedicated to the City on Block 3, Lots 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16 and 17 of the plat map for "Tract 1096 – Americana" as recorded

in the records of the Klamath County Clerk on July 25, 1975. The easement being rescinded and relinquished is depicted on Exhibit "A."


