
A tract of land situated in the N1/2 NE1/4 of Section 3, Township 40 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Beginning at a point on the North line of said Section 3, from which the Northeast corner of said Section 3 bears North 89° 54' 58" East 1,857.24 feet; thence South 00° 05' 02" East 30.00 feet to a 1/2 inch iron pin on the Southerly right of way line of Old Midland Road; thence continuing South 00° 05' 02" East 108.14 feet to a 1/2" iron pin; thence South 35° 07' 04" West 100.08 feet to a 1/2 inch iron pin; thence South 16° 46' 10" West 460.58 feet to a 1/2 inch iron pin in an existing fence; thence North 88° 56' 03" East generally along an existing fence, 1,661.74 feet to a 1/2 inch iron pin; thence continuing North 88° 56' 03" East 19.83 feet to the Westerly right of way line of the U.S.B.R. No. 3 Drain; thence along said drain right of way North 41° 57' 00" West 143.45 feet; North 20° 40' 00" West 560.90 feet to the North line of said Section 3; thence South 89° 54' 58" West 1,197.17 feet to the point of beginning, with bearings based on Survey No. 272, as recorded in the office of the Klamath County Surveyor.

Said parcel is also described as Klamath County Tax Assessor's Account No. 4009-00300-00200-000 and Property ID No. 91536

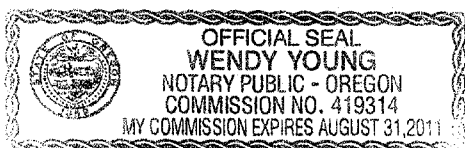


