STATUTORY WARRANTY DEED

Maria Salcedo, Grantor(s) hereby convey and warrant to **Heriberto Padilla**, Grantee(s) the following described real property in the County of **KLAMATH** and State of Oregon free of encumbrances except as specifically set forth herein:

LEGAL DESCRIPTION

The N1/3 of Lot 10 in Block of INDUSTRIAL ADDITION TO THE CITY OF KLAMATH FALLS, OREGON, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, described as follows:

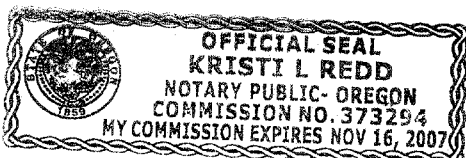
