KNOW ALL BY THESE PRESENTS this deed, made this <u>9th</u> day of November, 2007, between Michael R. Long, TAX COLLECTOR, Klamath County, State of Oregon, "Grantor", and KLAMATH COUNTY, a Political Subdivision of the State of Oregon, "Grantee";

RECITALS

Pursuant to ORS 312.100 the said properties attached hereto as "Exhibit B" were ordered sold to Klamath County, Oregon, subject to the right of redemption as provided by law. A General Judgment was entered in the Circuit Court of the Sate of Oregon for the County of Klamath on September 26, 2006, Case No. 06-00001FR in favor of Klamath County, Oregon, and against Joseph J. Adamick, et al.

The Tax Collector gave written Notice by both certified and regular first class mail to all persons entitled to redeem the property whose interests appeared in the records of the county as of the date the foreclosure proceedings were instituted.

A hearing was held on October 9, 2007, pursuant to a Notice of Hearing announced in the Herald and News on August 31, 2007. The Affidavit of publication of the notice was filed and recorded on September 20, 2007, in deed volume 2007-016597.
