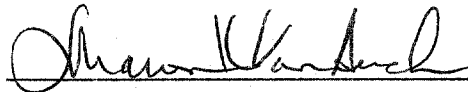
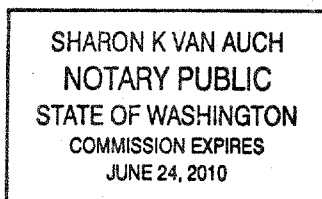

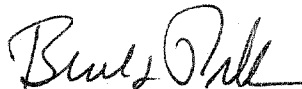

DEED OF RECONVEYANCE

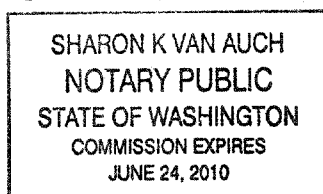

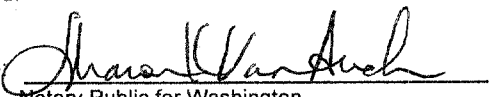
