KNOW ALL BY THESE PRESENTS this deed, made this 16th day of November, 2007, between Michael R. Long, TAX COLLECTOR, Klamath County, State of Oregon, "Grantor", and KLAMATH COUNTY, a Political Subdivision of the State of Oregon, "Grantee";

RECITALS

Pursuant to ORS 312.100 the said properties on the list attached hereto as "Exhibit B" were ordered sold to Klamath County, Oregon, subject to the right of redemption as provided by law. A General Judgment was entered in the Circuit Court of the State of Oregon for the County of Klamath on November 15, 2005, Case No. 05-00001FR in favor of Klamath County, Oregon, and against Elizabeth Ann Ada, et al.

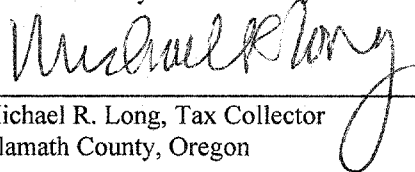
The said properties have been held by Klamath County, Oregon, for a period of two years from and after the date of the General Judgment, and no redemption has been made. The properties were not redeemed as provided by law.

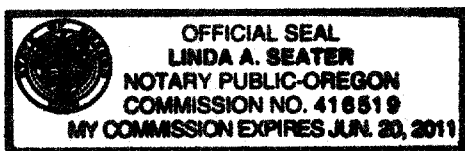
