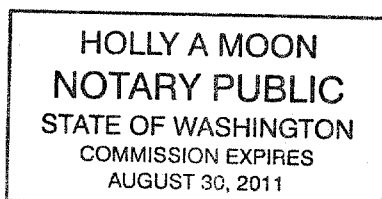
DEED OF RECONVEYANCE

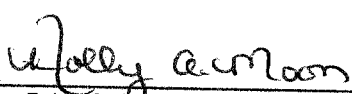
