#### LEASE ASSIGNMENT

### **RECITALS**

- A. Assignor is party to that certain Lease between **COLLINS PRODUCTS LLC**, an Oregon limited liability company ("**Collins**"), dated as of April 1, 1999 and recorded in the Microfilm Records of Klamath County, Oregon (the "**Records**") April 27, 1999 in Volume M-99, page 15628, covering certain real property located in Klamath County, Oregon as described below (the "**Property**").
- B. The lease was supplemented by that certain Supplement to Lease dated August 23, 2000 and recorded in the Records December 10, 2002 in Volume M-02, page 71864, which amended and replaced the property description attached to the Lease with the property description provided on attached Exhibit A. The Lease and the Supplement to Lease, together with any and all easement rights granted therein and any other documents relating thereto, whether or not specifically referenced, shall herein be referred to as the "Lease".
- C. Assignor desires to assign all of its right, title and interest in, to and under the Lease and the Property, including any associated easement rights, to Assignee.
- D. Collins has consented to the assignment of, and Klamath Energy has agreed to assume, the Lease by that certain Consent and Agreement to Assumption between them dated November \*\*\mathbb{E}, 2007.
