The true and actual consideration for this conveyance is **\$11,000.00**.

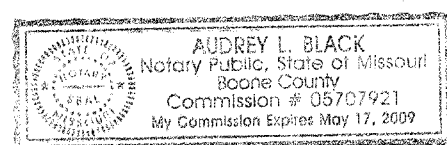
