KNOW ALL BY THESE PRESENTS that I, Mary Carol McLeehave made, constituted and appointed, and by these presents do hereby make, constitute and appoint Tracie V. Chandler

(b) on the date I am adjudged incompetent by a court of proper jurisdiction.

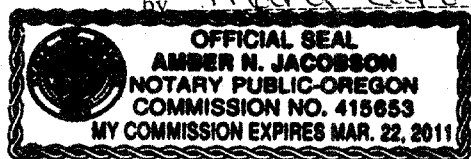
If neither phrase is deleted, this power shall take effect on the date next written below.
