According to the provisions of ORS 368.341(3) and ORS 368.351, a petition containing the acknowledged signatures of the owners of 100% of the property abutting the public property described in Exhibit "A", included hereto and by this reference incorporated herein, proposed to be vacated and indicating said owners' approval of the proposed vacation was filed with the Board of Commissioners on November 1, 2007.

Thereafter, the Planning Director filed with the Commissioners a written report containing the required information of ORS 368.346(1), finding the vacation to be in the public interest as found in the Order 2008-004, *Prepare a Planning Director's Report* approved on November 27, 2007.


Now, after fully considering the report and other documentation presented, the Board of County Commissioners find that the vacation of *Lot Lines common to Lots 6 and 7, Block 6, of Latakomie Shores Subdivision* located in Klamath County, Oregon, as described in Exhibit "A", included hereto and incorporated herein by this reference, is in the public interest and finds that the petition should be granted, and it should be noted that this property is already on the tax roll.





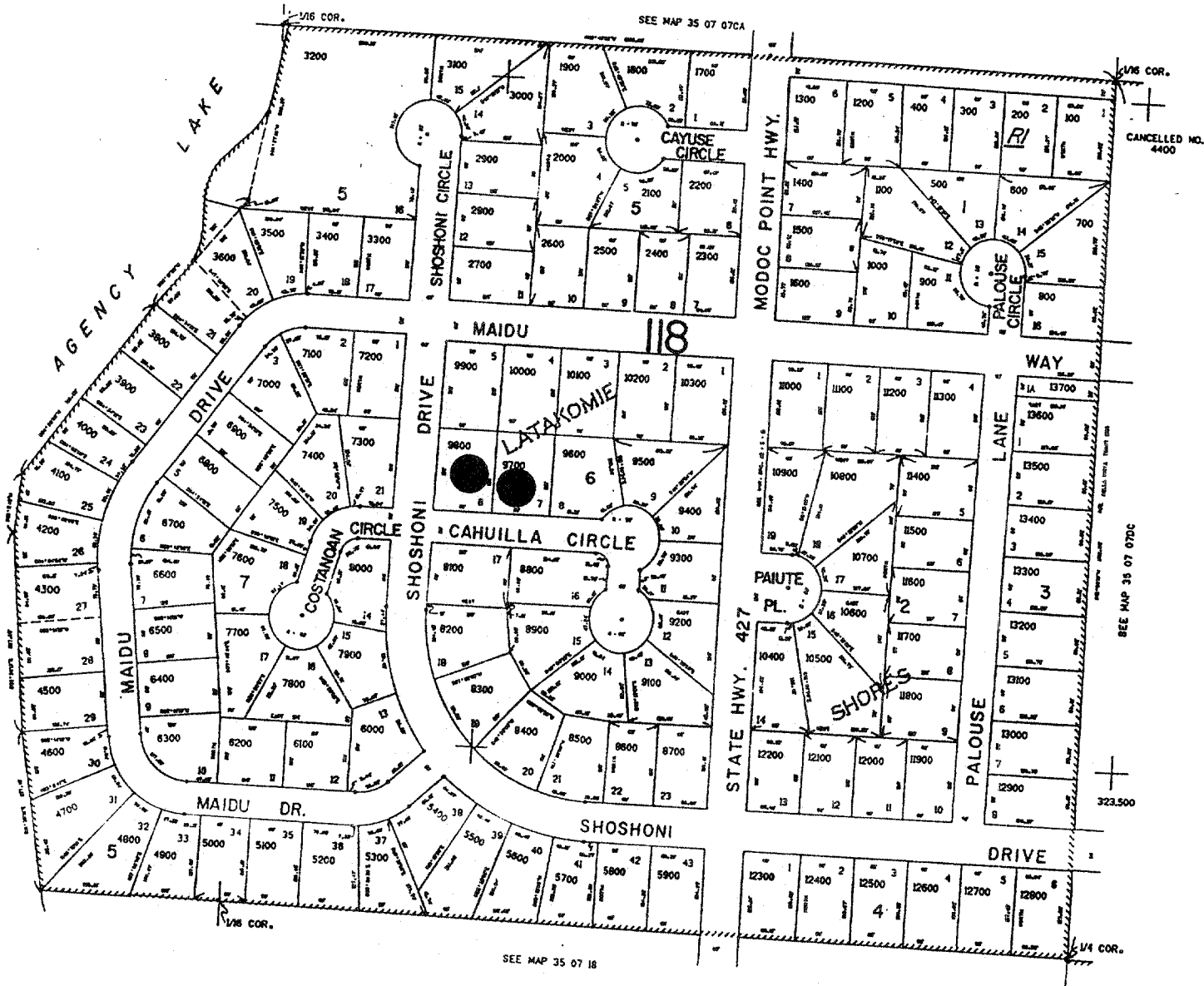
