To have and to hold, all and singular the premises, with the appurtenances, unto THE DALE N. BICKENBACH LIVING TRUST and his heirs and assigns forever.

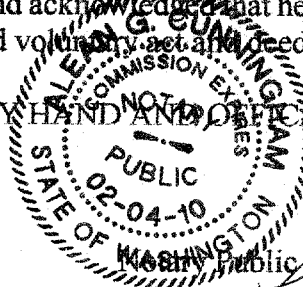
