DEED OF RECONVEYANCE

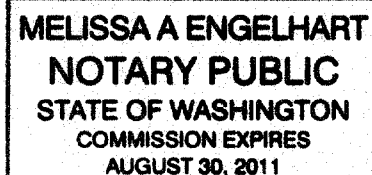
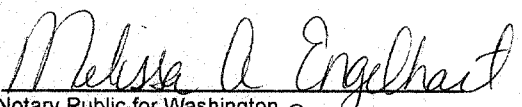
