## NOTICE OF DEFAULT AND ELECTION TO SELL

REFERENCE is made to that certain Trust Deed made by AZALEA BLALOCK, as grantor, and AMERITITLE, an Oregon Corporation, as trustee, in favor of ROBERT BELANGER and WENDY BELANGER, or the survivor thereof, as beneficiary, dated September 10, 2007, and recorded September 13, 2007, as Volume 2007, Page 016102, Microfilm Records of Klamath County, Oregon, covering the following described real property situated in the above-mentioned county and state, to-wit:
