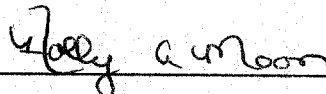

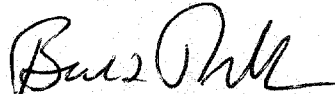

DEED OF RECONVEYANCE

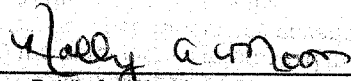
