





LEGAL DESCRIPTION

Lot 34 in Block 3 of TRACT NO. 1127, NINTH ADDITION TO SUNSET VILLAGE, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

EXCEPTING THEREFROM the Westerly 15 feet thereof.

TOGETHER WITH A tract of land situated in the SE1/4 SW1/4 of Section 12, and the NE1/4 NW1/4 of Section 13, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, being more particularly described as follows:

Beginning at the Northeast corner of Lot 34, Block 3, TRACT 1127 - NINTH ADDITION TO SUNSET VILLAGE; thence South $42^{\circ} 33' 00''$ West 150.00 feet to the Northerly Right of Way line of the U.S.B.R. "A" Canal; thence North $47^{\circ} 27' 00''$ West, along the said Northerly Right of Way line, 57.54 feet to the Southeast corner of said Lot 34, Block 3; thence North $63^{\circ} 32' 08''$ East 160.67 feet to the point of beginning, with bearings based on Lot Line Adjustment Survey No. 3440.
