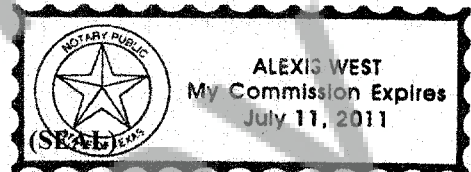

LEGAL DESCRIPTION
