## NOTICE OF DEFAULT AND ELECTION TO SELL

REFERENCE is made to that certain Trust Deed made by WILLIAM E. LEVIN, as grantor, and AMERITITLE, as trustee, in favor of RENEE L. CREASEY, as beneficiary, dated July 31, 2007, and recorded August 10, 2007, as Document No. 2007-014163, Official Records of Klamath County, Oregon, covering the following described real property situated in the above-mentioned county and state, to-wit:
