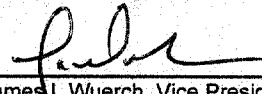
APPOINTMENT OF SUCCESSOR TRUSTEE

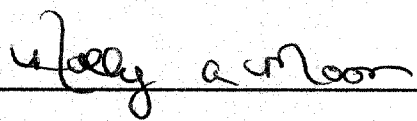

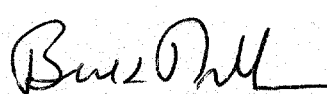

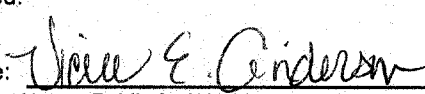
