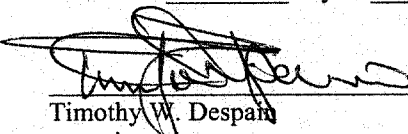
Lots 15 and 16 in Block 9, MIDLAND, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

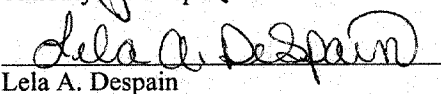

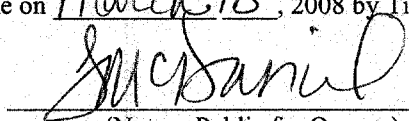

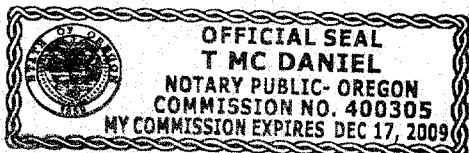
