NOTICE OF DEFAULT AND ELECTION TO SELL

REFERENCE is made to that certain Trust Deed made by **DAVID MONTERO AND DEBRA REPAYO**, as grantor, and **AMERITITLE**, as trustee, in favor of **EDGAR L. HURST AND VALERIE A.
